Definition of Services

Economy Infant, Adult, Cremains

The Cemetery retains ownership and control of grave spaces. Grave spaces are assigned at time of need. Only flat-and-flush markers are permitted over grave and remain unit spaces.

Lot Sales – Infant, Adult

Sale by recorded property deed of grave spaces, including cost of perpetual care. The charge for an infant gravesite is based proportionally to the size of an adult grave. Grave spaces are sold in combinations of two (pairs), three (triples) and twelve (family) grave plots. Subject to approval in advance by the Cemetery, twelve grave plots immediately adjacent to roads may be used for family crypts and small mausoleums.

Lot Sales – Historical Graves

Sale by recorded property deed of grave spaces that have been verified as having never been sold or used in earlier developed areas within the Cemetery.

Lot Sales – Reinstated Graves

As provided by Missouri Revised State Statute 214.209, after a period of seventy-five years since the last recorded activity on a burial site and after a reasonable search for heirs and beneficiaries, grave spaces are declared abandoned with the right of ownership reverting to the Cemetery.

Open/Close – Adult, Infant, Cremains

Preparation of gravesite for burial an adult, infant or cremation remains.

Open/Close – Cremains Niche

Preparation of in-ground cremorial niche, including nameplate, for cremation remains.

Additional Fee for Non-Office Hour Services

Services performed outside normal Cemetery Office hours of Monday through Friday, 9 am to 4 pm. **Requires advance confirmation by Cemetery Office and is subject to staffing availability.**

Disinterment Adult, Infant

Removal of remains from a gravesite including all related containers. Pursuant to Missouri Code of State Regulations 20 CSR 2120-2.060, a Missouri licensed funeral director shall be present and personally shall supervise any disinterment. **Funeral director and transportation costs are not included.** Reinterment fees apply in the event remains are moved to different location within the Cemetery.

Disinterment Adult, Infant

Removal of remains from a gravesite including all related containers. Reinterment fees may apply in the event remains are moved to different location within the Cemetery.
